Administrative Report -

Laurie S.

The Administrative Committee met and performed an audit of the RSC treasury in the interim time between RSC meetings. The following are the findings from this audit. David D. took over as RSC Treasurer in November of 2024. Prior to this, the treasurer was Yvonne S.

- David has a statement, minutes, checks, and a ledger to verify that someone said to spend it, that we have receipts, etc.
- Missing Receipts: 4 totaling \$271.97
 - 2 for \$216.15 (P&P for printing, 11/3/24)
 - 1 receipt for \$38.85 (NAWS, 11/17/24)
 - 1 receipt for \$16.97 (UPS, 4/22/25)
- One voided check (#1315 for \$298.96) is missing, pending its return from Star M.
- Bank statement fee went from \$5 charged and \$5 reimbursed to \$10 charged and \$5 reimbursed in December of 2024.
- Travel insurance was purchased and not returned in May of 2025 for \$. Why was travel insurance purchased at all? This was due to the AD's uncertainty in the ability to travel at the time and is not a normal occurrence.
- Twilio reimbursements to individual members who paid them on RSC's behalf should have a receipt and invoice attached.
- Final balance (pending outstanding items in August) matched between bank statements, ledger, and receipts. The Treasury was audited from August 2024 – July 2025.

Audit Procedures will be edited by the Communications Adhoc Committee. Procedure that may need to be changed in the Audit Procedure within P&P:

- Was there a separate ledger? Needs to be changed in procedure.
- Procedure implied that meeting minutes were to be printed out for reference during the audit.
- Suggestion: Include what was included in deposit slips in the ledger or on deposit slips.
- Reimbursements to individual members who paid them on RSC's behalf should have had a Reimbursement/Reconciliation Form filled out.

Website: There is a link so that any group, campout, or service body can “submit an event” directly at www.arscna.org. Please use this link even if you don’t have all the details or a flyer yet. It will help other Areas to show support by not scheduling several events on the same date when possible.

BMLT: All meetings have been updated that were received. The BMLT has been cleaned up and most unpublished meetings have been removed.

Phoneline: Updates to the patch list have been completed to include the members present at the last 3 phoneline workshops held virtually on zoom, in Crowley’s Ridge, and Northwest Arkansas Areas. We have a Phone Helpline training workshop today, November 01, 2025 @ 10AM in Searcy, Arkansas for the November Regional Service Committee. This workshop will provide RSC members with the opportunity to review the newly created orientation packet for feedback as we await to hear back from the Areas for approval to add to the listed phoneline resources on our Region website. **All phoneline volunteers must meet the 1-year clean-time requirement and have phoneline training every 2 years.** The NA Screens have been updated as well.

Calls per Area received: Below is a list of the calls received by the answering service, as recorded.

- 7/18/25-Caller was a representative of Whova App and was patched through to Convention Chair. The chair responded to the caller multiple times.
- 7/29/25-Caller was from House of Hope homegroup and was transferred to a helpline volunteer. Homegroup is requesting more “study books”.
- 8/6/25-Caller is asking for information on an upcoming event in Central Arkansas. Caller ended up hanging up after being transferred to 4 different volunteers’ voicemails. A helpline volunteer returned the call and provided information.
- 8/23/25-Caller needed to speak with a member and was patched to a helpline volunteer.
- 9/3/25- Caller needing to speak to someone in the CRANA area regarding local meetings. The caller was transferred to 2 members’ voicemails before the call was returned by a helpline volunteer.
- 9/29/25-Caller requesting information on starting a new group in the Arkadelphia area.

The answering service provided the requested information to the caller.

Twilio: I have added my personal address and debit card to get our phone line back in operation. Our Region Treasurer has reimbursed me in the amounts of \$10.94 for August and \$10.66 for October. The RSC Treasurer and I are getting together this weekend to try and add our new virtual address to our Twilio account in hopes of resolving this issue.

Basic Text for Jails Project Ad Hoc

Crystal S.

The Adhoc committee met on September 28, 2025, with an attendance of 6 people. Their goal is to have this project completed by the May 2026 Regional Service Committee Meeting.

The committee extrapolated a possible 60 jails throughout the state to send Basic Texts to.

- 33 of the 60 still need to be researched
- 23 of the 60 have not yet been contacted
- 8 need follow-ups
- **24 jails will be receiving NA Basic Texts with the first round of this project.**
 - 23 jails will allow us to send in soft-cover

- 1 wants it shipped from a distributor
- 5 of 23 allow virtual books. All but 1 of these will allow physical books as well.

The Basic Texts for Jails POA is requesting \$400 to ship the first round of books to jails. Next meeting is 11/23/25 at 5pm and is virtual.

Insurance Ad Hoc

Star M.

Recovery Connection's insurance agent referred me to a commercial insurance specialist who has provided quotes. I've asked him a couple of times to try harder, but so far the lowest quote—based on an average of 1,000 annual attendees—is \$3,020 per year. We can get certificates for events and similar needs, as needed, at no additional cost.

For comparison, Recovery Connection pays \$600 per year for one group at one location. I copied the regional meeting list and, with the help of my friends ChatGPT and Excel, determined that we have 85 locations hosting around 300 meetings.

I also reached out on the US Zones of NA Slack to see what other regions are doing and paying. I got a couple of leads, but I haven't been able to reach either of them after making a few attempts.

Communications Ad Hoc

Hi family, We held two meetings to review the regional guiding documents. As we were looking at the communication pieces, we took the opportunity to do a full review for other changes with the goal of making them easy to understand, easy to follow, and truly workable. Rather than just present them as a whole for your approval, I wanted to host a "working" workshop for us to review them, see if there are other changes that need to be made, and allow a holistic approach to approval before we present in motion.

Some of the major changes made include:

- Combining into one document – putting like material together, removing duplicative, or inconsistent statements
- Removed the social media materials into its own handbook
- Removed some of the treasury stuff into a treasury manual
- Additionally, the rest of the material was streamlined, updated, consolidated, and cleaned up unnecessary or unused language.

The document has "tracked changes" turned on, so you will be able to see all the changes that were made. However, we also cleaned up the spacing, fonts, margins, and numbers for consistency (e.g., there were many statements with a 1 or A, but no 2 or B so the numbering was removed). Those changes won't be marked as it would have made the document almost unreadable. Lastly, while we removed the index, a full index will be added to the end before final publishing.

If the body is amenable to a workshop to review these for approval, we can set a date today before adjournment. This would be a Zoom meeting so all who wish to attend are able.

Additionally, the drafts will be sent out after this meeting, so you have plenty of time to review before we meet.

If the body does not wish to continue with these changes, then I will submit a list of specific changes with regards to communications.

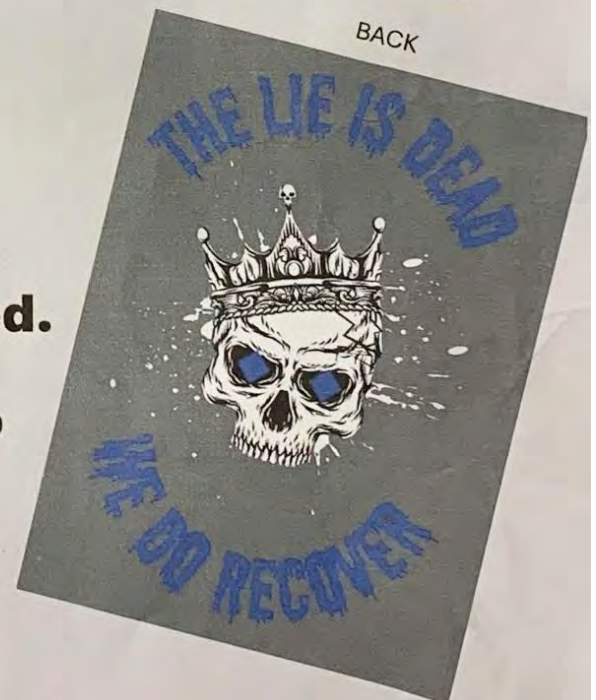

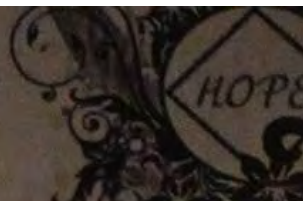
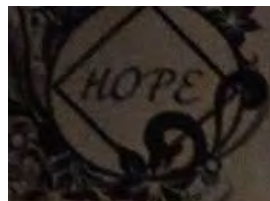
